

# NOTICE

Notice is hereby given that the Subic Bay Metropolitan Authority (SBMA), with office address at Bldg. 229, Waterfront Road, Subic Bay Freeport Zone, during the Seventy-First (71st) Meeting of its Board of Directors held on December 16, 2025, wherein there was a quorum to validly transact business, approved and ratified the following resolution:

## Board Resolution No. 25-12-1627

"Resolve, as it is hereby resolved, that upon recommendation of the management and without prejudice to COA regulations and pertinent laws on the matter, the Board hereby approves the proposed Implementation of the **PORT TARIFF ADJUSTMENT for FY 2025** on the following items:

1. *Implementation of the ten percent (10%) increase on cargo handling and miscellaneous charges of non-containerized/general cargoes. The increase shall be in three (3) tranches;*  
*1<sup>st</sup> Tranche – 4% January 2026*  
*2<sup>nd</sup> Tranche – 3% June 2026*  
*3<sup>rd</sup> Tranche – 3% December 2026*
2. *Implementation of the collection of the SBMA share from terminal operators/cargo handlers for liquid bulk cargo handling and related activities. The introduction of the tariff shall take effect in three (3) tranches; and;*  
*1<sup>st</sup> Tranche – 4% January 2026*  
*2<sup>nd</sup> Tranche – 3% June 2026*  
*3<sup>rd</sup> Tranche – 3% December 2026*
3. *SBITC's proposed Empty Storage Charges in Excess of the Allowed Free Pool Allocation at Subic Terminals (NCT 1 & 2) in accordance with the matrix below;*
